**22<sup>nd</sup> WORLD FIELD ARCHERY CHAMPIONSHIPS - 2010**

**TEAM NOMINATION CRITERIA**



## 1. OVERVIEW

- 1.1 The 22<sup>nd</sup> World Field Championships is a major event in 2010 and ARCHERY AUSTRALIA is intending to send a team to the Championships.
- 1.2 The 22<sup>nd</sup> World Field Championships will be conducted in Visgard Hungary from the 13<sup>th</sup> to 18<sup>th</sup> July, 2010.
- 1.3 Team funding will be in line with the current ARCHERY AUSTRALIA Team Funding Policy, all members of the team will be fully **SELF** funded, although Archery Australia will cover the cost of entry and uniform.
- 1.4 ARCHERY AUSTRALIA can enter a team of 18 senior archers, comprising up to 3 Men Recurve, 3 Men Compound, 3 Women Recurve, 3 Women Compound, 3 Men Barebow and 3 Women Barebow.
- 1.5 FITA also plans to conduct a junior championships and there can be a maximum of 18 junior archers entered: 3 Junior Men Recurve, 3 Junior Men Compound, 3 Junior Women Recurve, 3 Junior Women Compound, 3 Junior Men Barebow and 3 Junior Women Barebow.
- 1.6 It should be noted that if insufficient junior entries are received by the close of preliminary entries, FITA may choose to cancel the junior event, this will not be known by FITA until official close of preliminary entries 2 months prior to the championships.
- 1.7 ARCHERY AUSTRALIA will appoint a Team Manager and if team number warrant a Assistant Manager/Team Coach who will be responsible for the planning, preparation and conduct of the team during the championships.

## 2. PROCESS

- 2.1 To be considered for selection, archers must first:
  - a) Obtain the required Minimum Qualifying Score; and
  - b) Register with ARCHERY AUSTRALIA submitting the registration form and paying the registration fee.
- 2.2 Registration forms must be forwarded to the ARCHERY AUSTRALIA Inc Chief Executive Officer by 5pm on Monday 5<sup>th</sup> April 2010.
- 2.3 The Minimum Qualifying Scores are –

- 2.4 The Minimum Qualifying Score that must be achieved to permit registration is from a 24 Target marked FITA Field Round.
- 2.5 A Minimum Qualifying Score can be shot from 1<sup>st</sup> August 2009 in International, National, State and State sanctioned FITA Field events until Sunday 4<sup>th</sup> April 2010.
- 2.6 Selection for junior positions will be determined from scores shot during the 2010 National Youth Field Championships. Selection for the senior position will be determined from scores shot during the 2010 National Field Championships
- 2.7 Following the field events at the 2010 National Championships and National Youth Championships the ARCHERY AUSTRALIA High Performance Committee shall nominate the 3 highest ranked registered archers in each eligible category to the ARCHERY AUSTRALIA Board for ratification.
